Minutes of the 72nd Meeting of the Fleet Study Group, held at the Dorset Wildlife Trust HQ at Brooklands, Forston, Dorset on the 20th July, 2001

- 1. Notes of last meeting (23 March 2001) were accepted as a correct record.
- 2. Matters arising; none not already on the agenda.
- 3. Reports from representatives; none about the 10 May Dorset Coast Forum meeting since no-one present today attended that. Of the two Joint Dorset Marine Committee meetings, the only matters of particular relevance to FSG were in relation to (a) Dorset Central Marine Database which is now transferred to Dorset Environmental Records Centre, and volunteers will start inputting data, (b) DRS has contributed to a JDMC response to the planning application for a fuel bunkering proposal in Portland Harbour.
- 4. FSG Symposium Proceedings: joint editors (DRS,JW,PD) have now received all the papers which have been or soon will be sent for peer review.
- 5. Alan Carr obituary and memorial: JW has produced a full obituary and list of papers for publication in next year's *Dorset Proceedings*. DRS, DM and GLP are identifying appropriate survey points (see last minutes).
